- i) I, the undersigned, in consideration of and as a condition of acceptance of my entry in the 2010 Mt Wilson to Bilpin Bush Run (the Run), I declare that;
 - a. for myself, my heirs, executors and administrators, I hereby waive all and any claim, by way of my right or cause of action which I might otherwise have, or arising out of loss of my life, or injury, damage to myself or my possessions of any description whatsoever, which I may suffer or through my participation in the Run.
- ii) I understand that participating in the Run involves running and/or walking through a rugged, isolated and remote track through bushland. I am aware of the risks involved. The risks include, but are not limited to;
 - a. natural or manmade features, road or track surfaces, portions of which will involve ascending or descending steep inclines,
 - b. bushland and other natural or man made features,
 - c. the strenuous nature of running and/or walking 35 kilometres on foot, becoming lost, crossing waterways, vehicle traffic at the commencing and concluding points and approaches to those points where the Run is conducted,
 - d. actions of participants, spectators, organiser personnel, supporting agencies,
 - e. weather conditions, hypothermia and heat exhaustion,
 - f. condition of footwear or equipment.

I am aware that there may be other risks involved which have not been set out above.
- iii) I have read the race information sheet and race rules and agree to abide by the race rules and conditions of entry and participation. I understand that in reading this waiver and the race information sheet, I have received a warning as to the risks in entering and participating in the Run and that the warning is given on behalf of the NSW Rural Fire Service, National Parks & Wildlife, Hawkesbury City Council, Blue Mountains City Council, RTA and the State of New South Wales. I agree that I am participating in the Run at my own risk.
- iv) I attest and verify that I am physically fit and sufficiently trained for participation in this event and have not been advised by a qualified medical practitioner that I should not participate in the Run.
- v) This waiver, release and discharge shall be and operate separately in favour of all persons, corporations and bodies involved or otherwise engaged in promoting or staging the event and the servants, agents, representatives, volunteers and officers of any of them including but not limited to the participants and competitors taking part in the Run, the NSW Rural Fire Service, Hawkesbury City Council, Blue Mountains City Council, RTA, National Parks and Wildlife and the state of New South Wales.
- vi) I hereby grant full permission to use any photographs, videotapes, motion pictures, recordings or any other records of this event for any legitimate purposes.
- vii) In particular, I understand that my entry may be rejected up until the start time on 21 August 2010 at the Race Organisers discretion, even if I have signed this waiver and even though I have paid in full. Specific note is made that I agree with and understand the race postponement and cancellation procedure. I understand that evacuation to hospital and any medical or ambulance bills are payable by myself.
- viii) I certify that I am eighteen (18) years of age or older at the time that the Run is conducted.
- ix) I consent to my photograph being used on the Bilpin Bush Run Website for promotional purposes.
- x) I understand that I am obliged to inform the Run officials at any drink station or at the finish line should I retire from the Run for any reason for my own safety in order to avoid deployment of a search and rescue team to locate me after the race.
